

Privacy Policy

Instant Power Corporation respects your privacy and is committed to protecting your personal information that you provide to us. This statement explains our policies and practices regarding the use and disclosure of your personal information by us. We review and update this Privacy Policy on an on-going basis as needed, without notice. Therefore, you should review the terms of this policy periodically, such that you are aware of how we collect and use personal information. By using our Web site, you consent to the collection and use of your personal information by us, as defined below. If you do not agree with any term in this policy, please do not use this site to submit personally identifiable information.

The Information We Collect:

This notice applies to all information collected or submitted on the Instant Power Corporation website. On some pages, you can order products, make requests, and register to receive notification of upcoming product releases. The types of personal information collected at these pages are: Name, Address, Email address, Phone number, Credit/Debit Card Information, etc.

The Way We Use Information:

We use the information you provide about yourself when placing an order only to complete that order. We do not share this information with outside parties except to the extent necessary to complete that order.

We use the information you provide about someone else when placing an order only to ship the product and to confirm delivery. We do not share this information with outside parties except to the extent necessary to complete that order.

We use return email addresses to answer the email we receive, and notify customers of new products and periodic special offers. Such addresses are not shared, nor will they be shared with outside parties.

Receiving our product updates and announcements on special offers is by opt-in only. If you wish to not receive email of this nature, simply do not check the opt-in box. Recipients of products updates and announcements can opt-out at any time after receiving notification.

Finally, we never use or share the personally identifiable information provided to us online in ways unrelated to the ones described above without also providing you an opportunity to opt-out or otherwise prohibit such unrelated uses.

Testimonial Letters & Email:

Instant Power Corporation will occasionally publish the text, or portions of the text, of letters, email and filmed or recorded testimonials we receive which are complimentary, and exemplify our commitment to our customers. By submitting any such testimonial, you grant Instant Power

Corporation the right to publish the text and use it for marketing and promotional activities. Anonymity will be preserved for all people who submit testimonial letters for publishing. Only first names, last initials and city will be used to identify the sender.

Disclosure of "User Information"

Instant Power Corporation does not sell, trade or transfer "User Information" to third parties. However, we may share "User Information" with our business partners for marketing, advertising or product/service offering purposes. We only disclose your "User Information" if we have your consent, we need to share it in order to provide you with the products and/or services you have requested, or we respond to a court order. You may separately agree to provide your personal information to third parties that provide information for our products, in order to access and/or use their products and/or services. If you agree to provide such information to these third parties, then your personal information will be subject to their Privacy Policies.

Cookies

Instant Power Corporation may choose to use "cookies". A cookie is a small data file that a Web site can transfer to a visitor's hard drive to keep records of the visits to the Web site. A cookie contains information, such as your "User Information", to help us recognize the pages you have visited and improve future visits, but the only personal information a cookie can contain is the information that you provide yourself. A cookie cannot read data off of your hard drive, or read cookie files created by other sites. Information stored in cookies may be encrypted, however, we would not store any financial information in cookies.
